The company had posted a net income of USD 237 million in the corresponding period of the previous fiscal, Hindalco Industries said in a BSE filing. However, the net sales of the company in the July-September quarter increased to USD 4,799 million from USD 4,119 million in the year-ago period, the

filing said. "Net income attributable to its common shareholder decreased 23 per cent versus the prior year to USD 183 million, while net income from continuing operations decreased 23 per cent to USD 184 million," the filing said. The company is a global provider of sustainable aluminium solutions and is into aluminium rolling and recycling.

GCPL Jul-Sep consol PAT falls 25% to ₹359 crore

Consumer Products Ltd (GCPL) on Tuesday reported a decline of 25.06 per cent in its consolidated net profit at Rs 358.86 crore for the second quarter ended September.

It had posted a net profit of Rs 478.89 crore in the July-September quarter a year ago, GCPL said in a regulatory filing.
