Khamankar \& Co., Practicing Company Secretaries, Scrutinizer appointed by Bajaj Electricals Limited (the "Company") pursuant to Sections 108 and 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules 2014, as amended by Companies (Management and Administration) Amendment Rules, 2015, to the extent applicable, for the purpose of Scrutinizing the e-voting and Postal Ballot in a fair and transparent manner and ascertaining the requisite majority as per the provision of the Companies Act, 2013.

iii. The remote e-voting was disabled on Tuesday, $26^{\text {th }}$ March, 2019 at 5:00 p.m. (IST).
iv. The box containing the Physical postal ballots was opened on $26^{\text {th }}$ March, 2019 at 5:30 p.m. in the presence of two witnesses, Miss Gauri Mali and Miss. Kinnari Ghag who are not in the employment of the Company.
v. All postal ballot forms received/receivable up to the close of working hours (17:00 hours) on Tuesday, $26^{\text {th }}$ March 2019, the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny. Envelopes containing postal ballot forms received after $26^{\text {th }}$ March 2019, were not considered for my scrutiny.
vi. Thereafter considering remote e-voting and postal ballot voting, the combined result of the voting by equity shareholders is annexed as Annexure I. The details containing inter alia, list of Equity Share Holders, who voted "for" or "against", on each of the Resolutions that were put to vote, and whose votes became invalid or who abstained from voting, were generated from the e-voting website of Link Intime ie. instavote.linkintime.co.in and is based on such reports generated.
vii. Based on the aforesaid results, I report that the Resolution No. from 1 to 4, have been passed with requisite majority.
