Sub.: Grant of 1,40,000 Stock Options under Employee Stock Option Scheme 2015

We wish to inform you that the Nomination and Remuneration Committee of the Board of Directors of Bajaj Electricals Limited (the "Company"), at its Meeting held today i.e., on August 10, 2023, has approved the grant of 1,40,000 Stock Options under the Company's Employee Stock Option Scheme 2015 ("ESOP Scheme 2015") to 32 eligible employees at a price of Rs.1,246.70 per option, being the closing market price of the Company's equity share on the National Stock Exchange of India Limited, where the traded volume in the Company's shares was higher on August 9, 2023, i.e., the date previous to the date of the Committee Meeting.
